Introduction to the Course

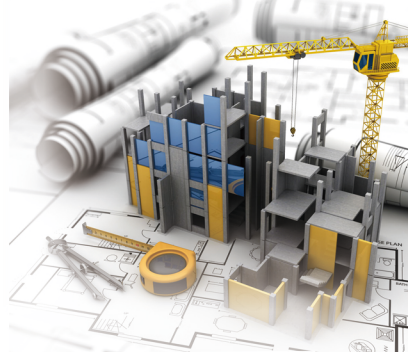

Course Structure

The course is offered in distance learning mode only. Student will need to study through Virtual Learning Environment. There are a total of 7 taught modules and each of them is bearing 20 credit points. Additionally, this course requires a 40 credit points module - Major Project. The entire course comprises of 180 credit points.

The following modules are offered:

1	Sustainable Construction	2	Research Methods
3	Building Economics	4	Procurement & Tendering
5	Construction Law Principles	6	QS Professional Practice
7	QS Commercial & Financial Management	8	Major Project (40 credit points)

Admission

Applicants should either have:

- At least a second class honours degree in a cognate subject ; or
- At least a second class honours degree in a non-cognate subject supported by evidence of an aptitude for the subject applied for, or
- Have equivalent experience or training, normally from within the work environment
- **AND** All applicants should be in relevant employment at the point of commencing the course
- **AND** All applications should be supported by a reference, either academic or professional
- **AND** English language proficiency requirements: IELTS 6.0 with no skills below 5.5 or equivalent; or Bachelor's degree (or higher qualification), taught and assessed in English from one of the countries on UKVI approved list (e.g. Australia, Canada, UK, USA etc.); or GCSE grade C

Application Method & Course Fee

This course consists of 8 modules. Students will normally register 2 modules per semester and the standard length of course is two years. Application forms will be downloadable from the website: www.aibe-edu.org, and AIBE will further assist you to proceed online application to the university.
